- The Board will seek guidance from committee regarding spending and potential planning options (i.e. healthy building, renovated k-wing, education enhancements, potential community needs).
- The Board will provide more concrete details regarding costs to the committee.
- Discussion with the State have been initiated regarding funding and they will be visiting the school in the near future.
- SWAT Analysis will take place.
- The committee will reconvene at the end of the summer.

Mrs. Diotte feels it has been a worthy process and is happy to engage the community.

Dr. Alexander noted the importance of the Bold Moves working group which may come into play when discussions arise regarding educational enhancements to the building. She also noted that the MOU will impact the project once the shared governance infrastructure has been established.

Mrs. Seeger suggested visiting one of the schools that Heidi Jacobs worked on. She noted a tour would be helpful, as well as hearing about the process from another district.
