Through consensus the BOE will allow Dr. Cosentino to negotiate a contract with Chartwell. All are aware this will cost the school district money, possibly \$25,000-\$30,000 for the year. We will look into lunch opportunities during this coming school year for the 2023-2024 school year.

#### 1.3. Review and Possibly Approve Revised 2022-2023 School-Wide Calendar

Mr. Berlandi made a motion to approve the revised 2022-2023 School Calendar. Mr. Vogt seconded the motion, which passed unanimously, 7-0.
